The Dublin Declaration was unanimously endorsed by delegates attending EUFAMI's special European Family Conference held in Dublin, Ireland on Friday, 24th May 2013 to mark the 20th Anniversary of the founding of EUFAMI under the patronage of his Excellency, Michael D Higgins, President of Ireland.

Grete Lundbeck European Brain Research Prize - The Brain Prize

Nominations are open for the Brain Prize 2014. This Prize recognises highly original and influential advances in research on the nervous system. If several researchers have contributed significantly to this achievement, more than one individual may receive the Prize. Nominees can be of any nationality but the research for which they are nominated must have been conducted in Europe or in collaboration with researchers in Europe. This Prize is intended to raise the visibility of European neuroscience and to be a stimulus to this important field of research. Triple A for Citizens: Access to Information, Advice and Active Help

The general objective of this EU funded project is to enhance 'the role of civil society in giving citizens a voice and holding governments to account'. By enhancing the connection to citizens, the project will strengthen the role of civil society. Citizen information and legal advice services are able by aggregating the complaints and evidence they receive, to influence government policy on key reforms and their implementation (priority no. 1 in the call). The aim is to spread the citizens' advice concept to Western Balkans and Turkey.
